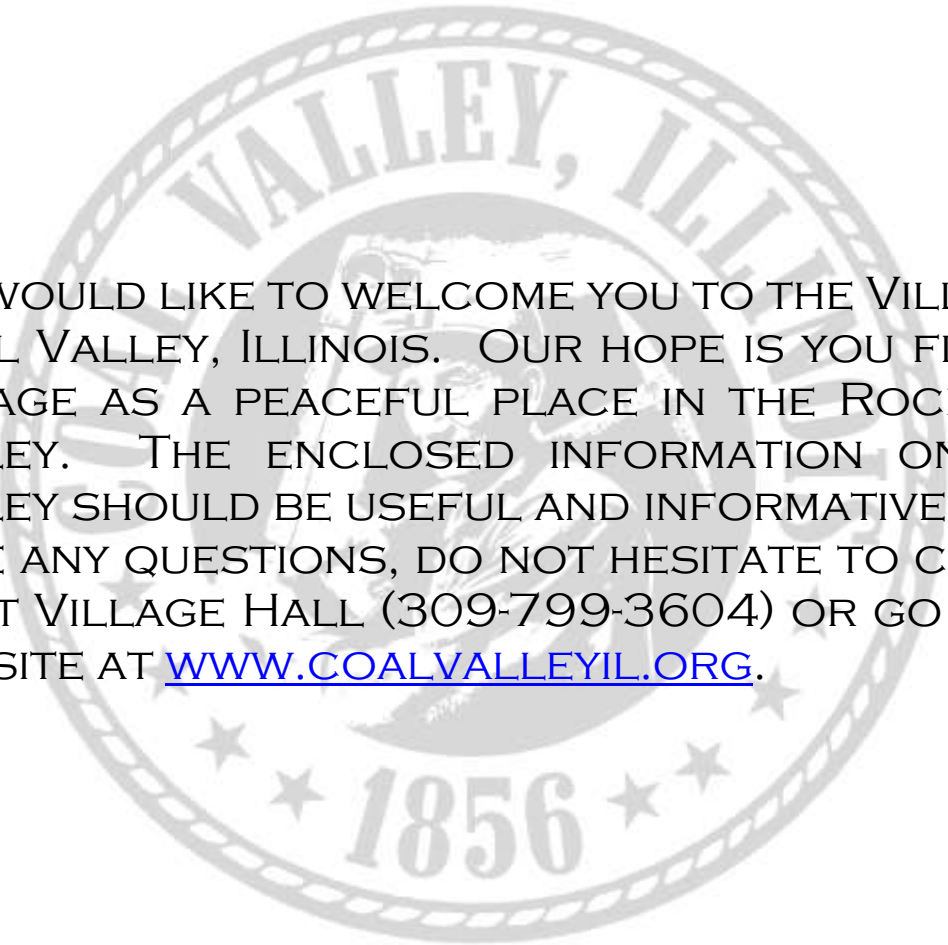


# VILLAGE OF COAL VALLEY

#### VILLAGE SERVICES

**PAYMENT & BILLING FOR WATER AND GARBAGE.** An administrative fee of twenty-five dollars (\$25.00) shall be charged to a new occupant for transfer of billing. In the case where the utility or finance department has not been made aware of the new occupant, a thirty-five dollars (\$35.00) administrative fee will be assessed for staff time preparing and posting notice to the property. These fees are non-refundable. A seventy-five (\$75.00) dollar deposit is due for occupants of a rental and will be refunded or applied to final billing.

The water meters are read on or about the 15<sup>th</sup> of each month and are billed on or about the 21<sup>st</sup> of each month. Payments are due by the close of business on the 10<sup>th</sup> of each month. Garbage is picked up every Tuesday, and recycling is picked up every other Tuesday unless the pickup day falls on a holiday, it would then be picked up the next day. All trash must be in your carts, no bags are allowed to be on the ground. All residents can have one “bulk” item picked up for free once a month and are picked up on Wednesdays, please call the Village Hall to schedule this. You can purchase yard waste stickers at the Village Hall and at Blackhawk Bank for \$1.75 each, all yard waste must be in craft paper bags with a yard waste sticker and are picked up on Wednesdays.

All bills for service shall be rendered monthly as of the first day of the month succeeding the period for which the service is billed and shall be payable no later than the close of business on the 10<sup>th</sup>

day of the same month. If payment is made after the 10<sup>th</sup>, then a penalty of 10% of the amount of the bill shall be added on.

Options to pay your bill: Mail the bill to the Village Hall, drop off the bill at the Village Hall (there is a drop slot for 24-hour service) or you can sign up for auto withdrawal, we also accept Visa, Mastercard & Discover. You can also go online to our website and sign up for auto payments through PSN.

If you plan on being away for a period of time you may wish to discontinue service. Any user desiring to temporarily discontinue service for a period of absence from the premises shall make application thereof to the Village. Each time there is a discontinuance of service requested by a user, there shall be a charge of \$20.00 to shut-off the service and \$20.00 to turn-on service, when your water is disconnected you will still be charged the \$12.50 service fee.

Trash service can be suspended if you are gone for two (2) months or more. Residents requesting refuse relief for garbage & recycle services that are invoiced by the Village, including vacant houses, snowbirds, etc. must submit an application request to the Village for temporary stoppage of service.

**BUILDING PERMITS.** Building permits are required for any construction or improvements and may be obtained at the Village Hall. When you obtain the permit please have your bid cost and drawings with you. Please contact the Village Hall for all inspections.

**PARK RESERVATIONS.** The Village of Coal Valley has two pavilions at the Coal Valley Municipal Park, which are available by reservation only. If you would like to reserve one of the pavilions in the Park for your event, please contact the Village Hall. There is a \$50.00 refundable deposit for reservations.

**NOTARY SERVICE.** The Village of Coal Valley has a notary on staff, if you need to have something notarized, please come down to the Village Hall during regular business hours, this is at no cost to the resident.
